WHY IS GCMC ACQUIRING BLUESTEM MEDICAL LLP?

Access to rural healthcare is a valuable asset that also presents many challenges, especially financially. We continue to see many facilities struggling to survive so joining and becoming one facility gives the best chance at continuing to provide exceptional healthcare in our rural community. In addition, there is increased federal funding with becoming one entity versus separate entities. Providing healthcare to our rural community is at the heart and soul of why the providers chose to practice here, raise their families here, and invest in this community. They want to make sure that legacy continues for many generations to come and joining GCMC strengthens the chances for stability.

WHAT DOES THE TERM "PROVIDER-BASED" MEAN?

This is a Medicare status for hospitals and clinics that meet specific Medicare regulations and requires that we bill Medicare in two parts (Part A and Part B).

HOW DOES THIS AFFECT THE BILLING PROCESS?

Since services will now be provided in a department of the hospital, Medicare, Medicare Advantage, and Medicaid patients will see separate charges, one for the provider and one for the facility. Patients with commercial insurance will not see separate charges.

Medicare, Medicare Advantage, and Medicaid beneficiaries are responsible for the co-insurance amount on the services they receive. These amounts are determined by Medicare, Medicare Advantage, and Medicaid and are based on the services performed. Medicare patients who have supplemental insurance may have coverage that will reimburse their co-pays and deductibles. Please check with your insurance plan.

The total cost of charges for Medicare, Medicare Advantage, and Medicaid patients will not exceed charges incurred by non-Medicare/Medicare Advantage/Medicaid patients receiving the same service.

WILL THERE BE A CHANGE IN HOW PATIENTS RECEIVE CARE?

No. Patients will continue to receive excellent quality care from their providers, and scheduling appointments and tests will be handled as they always have been in the past. However, there is a change in how GCMC will bill your insurance carrier for these services.

4 Reasons to Document Medical Records Properly

Properly documenting patient's medical records has always been important, but never more than now, given today's healthcare landscape where the government ties reimbursement to the quality of the medical record.

1. Communicates with other health care personnel

Documentation communicates the what, why, and how of clinical care delivered to patients. These records allow other clinicians to understand the patient's history so they can continue to provide the best possible treatment for each individual.

2. Reduces risk management exposure

Thorough and accurate documentation mitigates risks and reduces the chance of a successful malpractice claim. A well-documented record serves as evidence of treatment and care, helping to alleviate liability concerns in the event of a claim. It is unlikely you will remember details of a particular case several years later when you are in the middle of a professional liability claim. Your documentation will be the tool you rely on in this situation.

3. Records CMS Hospital Quality Indicators

Documentation captures value-based care metrics that, increasingly, the government is asking hospitals to provide. These include Hospital Quality Indicators and Merit-Based Incentive Payment System measures.

4. Ensures appropriate reimbursement

A well-documented medical record can facilitate effective <u>revenue</u> <u>cycle</u> processes, expedite payment, reduce any "hassles" associated with claims processing, and ensure appropriate reimbursement.

Other reasons why proper medical record documentation is important include:

- Tells the patient's "story," the presenting problem and the treatment received
- Helps to plan and evaluate a patient's treatment
- Creates a permanent record for the patient's future care

ecember is National Drunk and Drugged Driving Prevention Month, a time to raise awareness about the consequences of driving under the influence. The month of December was chosen to raise awareness because it's at this time of the year that our nation's roadways are at their busiest.

People travel all over to attend social events and holiday parties that involve alcohol. There is also an increase in traffic from the typical holiday traveling to visit friends and relatives. Data from the National Highway Traffic Safety Administration (NHTSA) shows that this increase results in more DUIs and fatal drunkdriving accidents.

Every day, nearly 30 people in the U.S. die in traffic accidents that involve an alcohol-impaired driver, according to the CDC. During the Christmas period, an average of 45 fatalities per day involves an alcohol-impaired driver. For New Year's, the numbers rise to 54 each day, according to the NHTSA. The U.S. National Institute on Alcohol Abuse and Alcoholism (NIAAA) reports that 40% of traffic-related deaths during Christmas and New Year's involve drunk drivers.

As you look forward to celebrating the holiday season in the coming month, it's imperative that you make smart choices. Under no circumstances is driving under the influence responsible or acceptable. Here are a few tips to keep in mind throughout the holiday season.

- <u>Remember your limits.</u> If you're not comfortable attending a holiday function where alcohol will be present, stay true to yourself and kindly turn down the offer. You shouldn't feel forced to go anywhere just because it's the holidays.
- Plan ahead. Have an exit strategy in place if you do decide to attend an event. This way, if you start to feel uncomfortable, you'll know what to do.
- <u>Drive yourself.</u> The person you can count on right now is yourself. It's
 a good idea to drive so that you can leave when you want, and you
 don't have to rely on someone else to get you home. Other ideas
 include bringing money to use public transportation or having a friend
 on call to take you home.
- Bring a trusted friend. Bring along a trusted friend to ride with you.
 They may help you feel more comfortable at the social gathering and motivate you to make smart choices.
- Have a drink (non-alcoholic). When you walk in, accept an alcohol-free drink. This will make you feel more comfortable, and it stops people from asking you if they can get you something. Sometimes, having nothing in your hands can make you feel more awkward.

But there are at least five modern-day medical technologies that seem to have been foreshadowed by science fiction writers.

THE TRICORDER (Inspired by Star Trek)

The Scanadu Scout is a small disk that you can hold between your thumb and forefinger. It begins registering physiological information once placed on the forehead. In Star Trek, a Tricorder was a hand-held scanner used by crew members to scan medical needs.

3D PRINTERS FOR ORGANS (Inspired by Star Trek)

In 2014, a biotech firm announced its intention of selling 3Dprinted liver tissue to allow for medical research on non-human organs. Star Trek fans will recognize the inspiration from the Replicator, which took the technology of a transporter and utilized it to dematerialize and then rematerialize matter into another form.

EMBRYONIC GENIETIC MODIFICATIONS (Inspired by Gattaca)

Gattaca, released in 1997, foretold a future where children could be genetically manipulated to guarantee they receive the best hereditary traits of their parents. In June 2014, National Public Radio published a story on its website detailing a new medical procedure that could prevent mitochondrial disease by utilizing DNA from three people, two women and a man, to create a single healthy embryo.

EXOSUITS (Inspired by Various Films and Comics)

Science fiction writers have maintained a long fascinations with enhancing humans with machine exoskeletons. There was highlighted in movies such as Iron Man and RoboCop. In 2014, the Food and Drug Administration approved a robotic device called ReWalk to assist individuals with lower-body paralysis from a spinal cord injury. The device allows paralyzed individuals to sit, stand and walk with assistance.

BRAIN-CONTROLLED PROSTHETIC LIMBS (Inspired by Star Wars)

In Star Wars: The Empire Strikes Back, Luke Skywalker lost his hand in a lightsaber duel. He returns in Star Wars: Return of the Jedi with a fully-functional bionic hand. In 2013, the Defense Advanced Research Projects Agency, (DARPA) began to develop a nerve electrode system that would allow amputees affixed with a prosthetic hand to experience sensitivity to touch. The company has mad significant advances in this technology including studies to allow a subject to control a prosthetic are with his or her mind.
