# Can RFK Jr Make America's Diet Healthy Again?

obert F Kennedy Jr has set his sights on changing how Americans eat and drink.

From the dyes in Fruit Loops cereal to seed oils in chicken nuggets, Kennedy - who is President-elect Trump's choice to lead the Department of Health and Human Services (DHHS) - has long spoken out against ingredients that he says hurt Americans' health.

But if Kennedy hopes to target junk food, he will first have to shake up the country's food regulations - and run up against Big Food.

Leading up to the election, Kennedy - a former Democrat - offered several ideas for tackling chronic diseases under his slogan "Make America Healthy Again".

He has frequently advocated for eliminating ultraprocessed foods - products altered to include added fats, starches and sugars, like frozen pizzas, crisps and sugary breakfast cereals, that are linked to health problems like cancer, cardiovascular disease and diabetes.

He has taken aim primarily at school lunches, telling Fox News: "We have a generation of kids who are swimming around in a toxic soup right now."

Part of Kennedy's new mandate will include overseeing the US Food and Drug Administration (FDA), which has over 18,000 employees.

The agency is in charge of ensuring the safety of pharmaceuticals and the US food supply, but has come under fire in recent years from some lawmakers and consumer groups, who have accused it of a lack of transparency and action on food safety.

The 70-year-old has pledged to take a sledgehammer to the agency, and fire employees he says are part of a "corrupt system".

He has also pushed for getting rid of food dyes, including Red No. 3, and other additives banned in other countries.

The former

Democrat has also singled out more



controversial health issues, including fluoride in drinking water, which he says should be banned altogether, and raw milk, which he believes has health benefits despite the increased risk of bacterial contamination.

Several public health experts stand behind Kennedy's goal to tackle ultra-processed food, which they say the US eats at much higher rates than many other countries.

The FDA has pushed back on Kennedy's claim that the US allows thousands of additives that are banned in the European Union. A spokesperson said it was necessary "to dig deeper and understand the context behind the numbers" when comparing regulations in the US and EU, which use different methodologies.

But public health experts and former officials said a number of Kennedy's goals were not worthwhile and in some cases, harmful.

For instance, drinking raw milk that has not been pasteurized - a process that helps kill bacteria - can make people sick or even kill them, research has found.

Food reforms, while long part of the public health conversation, could also simply be unrealistic both politically and bureaucratically.

# National Stalking Awareness Month

anuary 2025 marks the twenty-first annual National Stalking Awareness Month (NSAM) and the second annual Stalking Awareness Day of Action on January 18th! Both are a call to action to recognize and respond to the serious crime of stalking.

While awareness and public discussion of intimate partner violence and sexual assault have increased in recent years, stalking remains frequently misunderstood and rarely discussed – both within the fields of domestic and sexual violence and among the broader general public. Dating abuse and/or sexual assault educators have an incredible opportunity to increase knowledge about this commonly co-occurring crime.

Most victims of stalking talk to a friend, family member, or someone else they know and trust about the situation before pursuing any sort of professional or legal help. If a stalking victim talks to you, your response significantly impacts if they feel validated and/or seek help.

Stalking impacts 1 in 3 women and 1 in 6 men in the United States. Yet, there is no stalking hotline, no stalking crisis centers, and it is often difficult for stalking victims to recognize what they are experiencing and/or know where to go for help.

Unlike most crimes which require a single incident to establish probable cause, stalking requires a pattern of behavior or course of conduct consisting of two or more incidents. The incidents that make up a course of conduct in a stalking crime are often not criminal on their own (for example, sending gifts). These incidents only

become criminal when considered along with the context and intent of stalking.

In Kansas, as in most other states, stalking is a crime. Kansas statute states Stalking must contain (1) intentional harassment; (2) course of conduct, not single action; (3) targets a specific person; and (4) places a reasonable person in fear for the safety of a specific person and/or immediate family member. A stalking charge could be a Class A misdemeanor or a felony offense, depending on how a defendant is charged.

Stalking victims can request a protection from stalking order, even if the stalker hasn't been arrested or charged. A protection order can last up to one year, but can be extended for up to two more years or the rest of the defendant's life if the court finds that the order has been violated. Either party can file a motion to modify the order. If you or someone you know feels their being stalked, report the incident to your local law enforcement.

# DEADLINES

#### PLAN A

# December 31, 2025

40 points must be displayed in the portal by 12/31/25 in order to receive your \$480 (\$40/month) premium incentive discount for 2026. 20 points will earn you a \$240 (\$20/month) premium discount for 2026.

# PLAN C, J, and N

# November 15, 2025

Points must be displayed in the portal by 11/15/25 in order to receive <u>up to</u> \$500 in your Health Savings Account. Rewards are deposited at <u>\$12.50 per credit</u> directly into your HSA account throughout the year, so the amount deposited depends on how many points you earn. 40 points earns \$500.

# December 31, 2025

- Opt Out means you will receive your tax forms in the mail.
   You can also view and print them from your Paylocity account.

You may contact HR for instructions on how to opt in or opt out.

**January 3, 2025** - This is the last day you have to inform HR if you have a change of address so that your tax forms will be sent to your current address.


### Jenna Harvey Radiologic Technologist
